ORGANIZING AUTHORITY: The Lake Eustis Sailing Club

HOST ORGANIZATION: Lake Eustis Sailing Club located at, 1310 CR 452, Eustis, Fl., 32726. The club is approximately 40 miles northwest of Orlando, Fl.
This Regatta will coincide with the MC Scow Train Wreck Regatta.

ENTRIES AND ELIGIBILITY:

The Regatta is open to all Wayfarer and CL16 Class sailboats.

There will be two separate classes:

Spinnaker: both skipper and crew required, and

Non-Spinnaker: may be sailed crewless; use of spinnakers is prohibited.

RULES: The races will be governed by the rules as defined by The Racing Rules of Sailing, the Wayfarer Class Rules, the Sailing Instructions, and the NOR.

REGISTRATION AND FEES: Registration is \$80.00 for entrants registered before February 2, 2017, and \$90.00 for registration at the door. Registration will be available online at regattaregistration.com . Payment will also be accepted at the club and is to be made in US funds only. Credit cards accepted. The honor system continues. If you notify David Hepting or Patricia Kuntz of your intent to participate by January 15TH, 2017, you can pay \$80.00 when you get here.

Registration includes breakfast for all three days, and dinner on Saturday evening for skipper and crew. Saturday dinner for guest can be purchased for \$15.00, if ordered via registration before February 2, after which additional lunches and dinners cannot be guaranteed.

Lunches for skipper, crew and guests are \$8.00 each.

SCORING:

The low point scoring system, as outlined in App. A of the RRS will apply with one throw-out if four or more races are sailed. One or more completed races will constitute a regatta.

TROPHIES:

Keeper prizes will be awarded for the top three finishers in each class.
